100 Club Rules

1. The 100 Club will be operated under the Gambling Act 2005, which deals with lotteries for small societies. It is registered with Warwick District Council (Licence WDCL0T00380). The Promoter will be the Chair of the Talisman Theatre Company. In the case of a dispute the Promoter's decision shall be final.
2. The Theatre reserves the right to alter the rules of the 100 Club, from time to time, as may be necessary. A copy of the current rules will be available at the Theatre and on our website.
3. The object of the 100 Club is to raise funds to support the Talisman Theatre and its development.
4. The lottery will be limited to members of the Talisman Theatre Company, their family and friends over the age of 16 years.
5. The subscription will be £5.00 per month for 12 months (1st June to 31st May), payable by monthly direct debit prior to the 25th May 2021 and on the 25th of each month thereafter. The draw will take place on the last Wednesday of the following month, commencing June 2021. Participants joining after 25th of each month will pay for the remaining full months of the year and will only be entered into those draws.
6. On receipt of payment the applicant will be allocated a draw number.
7. A participant may buy more than one ticket.
8. A draw will take place every month for 3 prizes. The Prizes shall be £150 first prize, £75 second prize, and £25 third prize, based on all 100 tickets being sold. Should fewer than 100 tickets be sold then the prizes will be reduced pro rata. Should more than 100 tickets be sold the prizes will be increased pro-rata. Winners of prizes will receive a cheque and the results of the draw will be open for inspection and published at the Theatre, in the Talismag and on the Theatre's website. Half of the total subscriptions received each month will be paid out in the form of prizes.
9. The draw will be conducted every month by two unrelated people.
10. A 100 Club participant will not be included in the draw if the appropriate subscription has not been received by the due date as set out in (5) above.
11. Participants can cancel their entry into the lottery at any time by giving one month's written notice to the promoter. Under no circumstances can any payments be refunded. Any decision by the Talisman Theatre Company to wind up the 100 Club will also be made by giving one month's written notice. Should any monies still be held in trust for future draws following the winding up of the 100 Club these will be returned.
